

INVITATION TO BID FOR THE PROCUREMENT OF ONE (1) BRAND NEW MOTOR VEHICLE

The Philippine Embassy in Wellington, New Zealand, through the General Appropriations Act of FY2019, intends to apply the sum of seventy thousand New Zealand dollars (NZ\$70,000.00) being the Approved Budget for the Contract (ABC) to payments under the contract for the procurement of one (1) brand new motor vehicle as official car. Bids received in excess of the ABC shall be automatically rejected at bid opening.

The Philippine Embassy in Wellington, New Zealand now invites bids for the procurement of one (1) brand new motor vehicle as official car, with the following basic specifications:

12-seater van

Engine displacement

2500 cc to 3000 cc

Fuel

Diesel

Transmission Exterior color

Automatic Gray/Silver

Canvas seat cover

Warranty

Maximum of 3 years' warranty, with additional 2 years

(within the budget)

Delivery of said vehicle is required within six (6) months from the date of the signing of the contract.

Bidding will be conducted through open competitive bidding procedures using a non-discretionary "pass/fail" criterion pursuant to the guidelines of the Philippine Government Procurement Reform Law (R.A. No. 9184) and Annex "A" of the Government Procurement Policy Board (GPPB) Resolution No. 28-2017.

Bidding is open to all interested bidders, whether local or foreign.

The Philippine Embassy in Wellington, New Zealand will hold a Pre-Bid Conference on 14 October 2019, Friday, at 3:00 P.M. at the Sentro Rizal of the Philippine Embassy located at 50 Hobson Street, Thorndon, Wellington, which will be open to all interested parties.

Bids must be received by the Bids and Awards Committee of the Philippine Embassy at 50 Hobson Street, Thorndon, Wellington on or before 11:00 A.M. of 18 October 2019, Friday. Bid opening shall be held on the same date at 3:00 P.M. in the presence of the Bidders' representatives who choose to attend at the address above-specified. Late bids shall not be accepted.

The Philippine Embassy in Wellington, New Zealand reserves the right to accept or reject any bid, to annul the bidding process, and to reject bids at any time prior to contract award, without thereby incurring any liability to the affected bidder or bidders.
