The Consular Officer may require (1) the personal appearance of an applicant for interview and (2) the submission of additional supporting documents, as he may deem fit under the circumstances.

Additional Entry Requirements for Minor Foreign Nationals:

Minor children below 15 yrs. old traveling to the Philippines Unaccompanied by or not Joining a Parent in the Philippines

A Waiver of Exclusion Ground (WEG) Under Section 29(a)(12) of the Philippine Immigration Act of 1940, as amended is required for children below 15 yrs. old who are traveling to the Philippines unaccompanied by or not joining his/her parent/s to the Philippines.

The WEG Order will be issued by the Bureau of Immigration (BI) at the port of entry upon submission by the WEG applicant of the following requirements:

- Affidavit of consent by either parent or legally appointed guardian of the child, naming therein the person who will be accompanying the child to the Philippines and with whom the child will stay while in the country. The said Affidavit must be duly notarized by a local notary public or the consular officer at the Philippine Embassy or Consulate in the applicant's country or residence;
- 2. Original and copy of parent's passport;
- 3. Clear photocopy of the data page of the child's passport;
- 4. Clear photocopy of the Birth Certificate of the child;
- 5. Clear photocopy of the data page of the passport of the accompanying adult or guardian;
- 6. Clear photocopy of air ticket; and
- 7. Payment of immigration fees.

Extension of Authorized Period of Stay in the Philippines.

In case a temporary visitor visa holder will exceed his initial authorized period of stay in the Philippines, he/she will have to report to the Bureau of Immigration, secure an extension of stay and pay the corresponding immigration fees. Information on fees for extension of stay and other Immigration fees are available at the Bureau of Immigration website (www.immigration.gov.ph).
