

NO-VISA ENTRY FOR 30-DAY STAY UNDER EXECUTIVE ORDER 408

Countries whose nationals may enter the Philippines without a visa for a stay not exceeding thirty (30) days under Executive Order 408, provided these foreign nationals are holders of a passport valid at least six (6) months beyond the period of stay in the Philippines and return or outward bound tickets to country of origin or next country of destination:
